## Secretary's Minutes: June 2019 Page 1 of 2

## NOTES OF INTEREST

This Sunday the Idaho Statesman will run a story, "If the Bureau of Land Management shifts operations to the West, who are the winners and losers? Rocky Barker takes a look.", about the BLM shifting operations to the West. A little introduction is below. The story should be interest reading and give a little insight to coming changes. Most likely a good change; administrators will be more in touch with what they are dealing with.

**Bureau of Land Management HQ Heads West:** The Trump administration announced plans to begin relocating the Bureau of Land Management (BLM) headquarters, with a number of BLM employees relocating to Grand Junction, Colorado by the end of the year. Under the plan, 225 staffers would work in Colorado, Nevada, and Utah, while 75 would be posted to BLM state offices. Approximately 60 employees would remain in Washington and work on regulatory and budget issues. Senator Cory Gardner (R-CO) praised the administration's plan, saying "Ninety-nine percent of the land the BLM manages is West of the Mississippi River, and so should be the BLM headquarters."
